The Ministry of Municipalities and Public Works has applied for financing From International Development Association (IDA)] toward the cost of the Emergency Water Supply Project and it intends to apply part of the proceeds toward payments under the contract for assembling testing and commissioning of a Water Treatment Plant having a net output of 1.000 m3/hr of drinking water, complete of services and ancillary items and replacement of pipelines is about 40km length.

The Ministry of Municipalities and Public Works intends to prequalify contractors for Construction of Works comprising (1) a raw water intake,(2) WTP with capacity of 1,000 cubic meters per hour,(3) pumping station (4)treated storage tank (5)treated water transitions pipeline and(6)replacement of about 40 km of pipes of various diameters in the water distribution network and house connections.

The applicant shall have strong and proven records in construction and capable of demonstrating sufficient technical, financial and magrial capabilities to under take the execution of the contract. Applicant shall also have an annual value of construction work not less than US\$ 20,000,000 million and shall have completed one or more projects in similar complexity and of value not less than 15,000,000US\$ over the last 5 years. It is expected that invitations to bid will be issued in July 2008.

Prequalification will be conducted through prequalification procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, May 2004, and is open to all

bidders from eligible source countries, as defined in the guidelines.]

This invitation for bids follows the general procurement notice for this project that appeared in development busi- v, ness issue Issue No.642 dated November 16.2004..The GPN was published in dgMarket on October 12.2004 and UNDB ON-line on October 14,2004

2. The Ministry of Municipalities and Public Works has received a Grant from the World Bank Iraq Trust Fund administrated by the International Development Association toward the cost of Emergency Water Supply, Sanitation and Urban Reconstruction Project, and it intends to apply part of the proceeds of this Grant to payments under the Contract for Implementation of Saif Saad Neighborhood Sewage and Storm water Project in Karbala, contract number ICB / Saif Saad /W 01 / 08

The Ministry of Municipalities and Public Works now invites sealed bids from eligible and qualified bidders for Implementation of Saif Saad Neighborhood Sewage and Storm water Project in Karbala.

The project is composed of the following parts:

A. Saif Snarl Neighborhood Storm water Nelivork;

The total length of the network will be about 9,000 meters of uPVC pipes with pipes diameters from 315 mm to 600 mm. In addition, the network will also includes GRP pipes; with diameters from 700 mm to 900 mm. The network shall be connected to pumping station P 3-5. The network will also include ramps, backdrops, gullies, etc. B. Saif Saad Neighborhood Sewage Network;

The total length of the network will be about 16,500 meters of uPVC pipes with pipe diameters from 250 mm to 400 mm. The total number of manholes will be 560. The network also includes ramps, backdrops and house connections. It should be connected to the main trunk line, MS 3-1, which is being implemented by the Ministry. C. Pumping Station P 3-S;

The storm water network- shall be connected to this pumping station. The station shallbe provided with seven (7) cen-

trifugal 1 Non-Clog pumps with vertical motors and shifts, with flow rate at 175 liters per se,:o::~ each, head at 18 meter and power 72 kw.

The storm water from Thubat Al Usrah will be connected to this pumping station. The station shall bo p*rev_red with four (4) centrifugal 1 Non-Clog pumps with vertical motors and shifts, with flow rate at 262 liters per second each, head at 16 meter and power 77 kw.

The construction period is Twelve (12) months.

The similarity shall be based on the physical size, complexity, methods/technology or other characteristics as described in Section VI, Employer's Requirements of the bidding documents.

b) For the above or other contracts executed during the period stipulated in (a) above, a minimum experience in the following key activities:

1. Supply, installation, commissioning and operation of Centrifugal Non-Clog Vertical pumps with flow rate at least 265 liter/second at head at least twenty (20) meter.

2. Supply and installation of steel sheet piling for trenches.

3. Dewatering of ground water.
